TERMS OF REFERENCE

The Harris Centre shall lead the public review process for the Application by Husky Oil Operations Limited for the White Rose Development Plan and Benefits Plan Amendments for the WREP (the "Application").

In conducting the Work, the Harris Centre will:

- within 90 days upon receipt of the Application, carry out a public review of the Application in the context of the matters dealt with in the *C-NLOPB Development Plan Guidelines and the Benefits Plan Guidelines* and establish, host and promote a website to solicit the public's input on the application;
- post a description of the WREP on the host website in a format that is suitable for the public including:
 - Development Plan Amendment;
 - Benefits Plan Amendment;
 - SEIS Update;
 - Concept Safety Analysis; and
 - Any supplementary information provided in response to staff's completeness review.
- post a description of the regulatory approval process on the website.
- conduct public information sessions at the direction of the Board to further assist the public in understanding the WREP. It is contemplated that four sessions will be conducted in Placentia (2) and St. John's (2) at venues determined by the Harris Centre; and
- provide a report within 30 days following the completion of the public review, summarizing the issues and concerns brought forward by the public. The issues and concerns arising from the public review process will be taken into account by the Board's staff in its analysis of the Application and its recommendations to the Board.
- ensure the host website and/or the information contained therein shall remain active for at least a period of two (2) years after the completion of the public review.

TERMS OF REFERENCE

The Harris Centre will not:

• include in the review matters relating to an examination of questions of energy policy, jurisdiction, the fiscal or royalty regime of governments, the division of revenues between the Government of Canada and the Government of Newfoundland and Labrador, or any other matters that go beyond those in the *Development Plan Guidelines or Benefits Plan Guidelines*.

Any submissions received by the Harris Centre during the public review process shall be made available to Husky and posted on the website. The report of the Harris Centre will also be posted to its website.

The Board will:

- provide a description of the development plan approval process to the Harris Centre including its purpose and objectives relative to the more detailed regulatory approval process associated with an operations authorization; and this description will be included on the website.
- once the application is determined to be "complete", advise the Harris Centre that the Work should commence and provide the Harris Centre with all non-confidential documents filed by the Proponent in connection with the Application for posting on its website. The documents to be posted will include:
 - Development Plan Amendment;
 - Benefits Plan Amendment;
 - SEIS Update;
 - Concept Safety Analysis; and
 - Any supplementary information provided in response to staff's completeness review.
- provide a link to the completed environmental assessment to the Harris Centre.
- prior to the Harris Centre conducting the public consultations, make staff available to assist the Harris Centre in the understanding of the regulatory process for a public review of a development and benefits plan.
